

Free ME from Lung Cancer held its Save Your Breath 5k on November 5th at the Kennebec Valley YMCA. The course venue was the Kennebec Rail Trail. More than 150 people came out to run/walk in support of lung cancer patients and their families. FMFLC raised more than \$45,000. Next year's event will be held November 4th.
